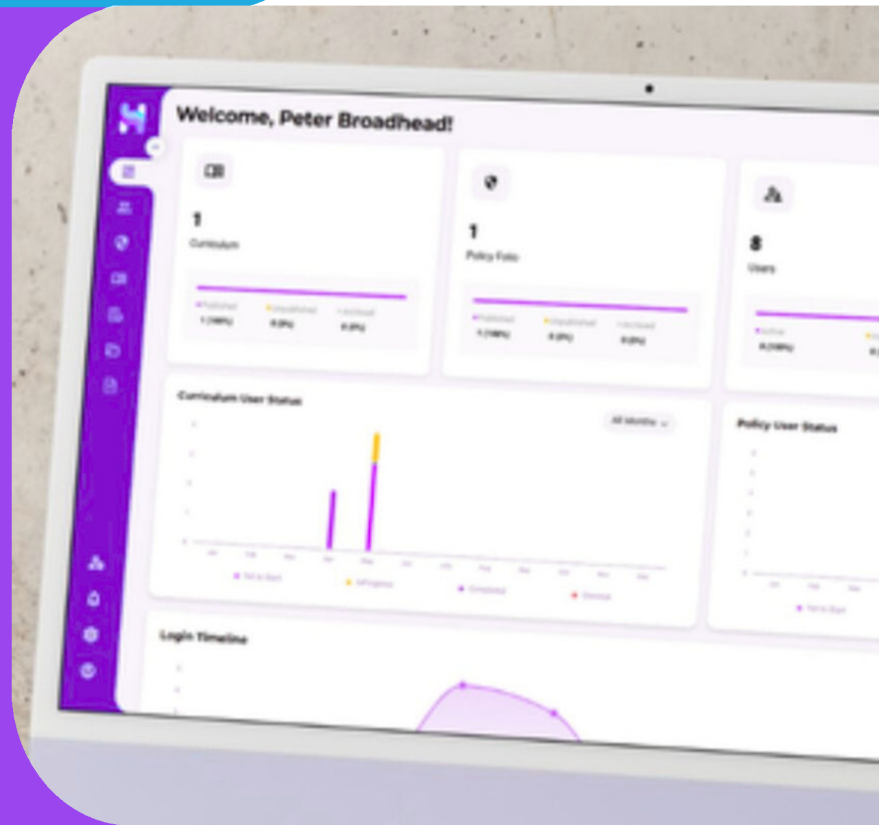

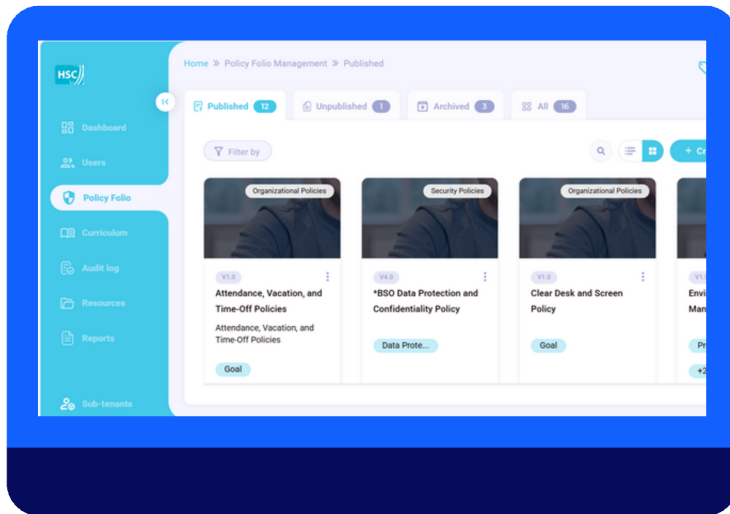
- **Announcement** – Share important updates or news with verified acknowledgment.
